ISCO International Unveils High Performance Duplexer / Filter

ELK GROVE VILLAGE, IL -- 09/25/2007 -- ISCO International, Inc. (AMEX: ISO), a leading provider of radio-frequency management and interference-control systems for the wireless telecommunications industry, announced today the release of a new state-of-the-art duplexer / filter solution within its RF2 family of products.

The new high performance duplexer / filter product provides unprecedented adjacent frequency band protection and has just completed field evaluation with a major US CDMA wireless operator. The test site location is severely encumbered by high power Air-To-Ground (ATG) and Safety Mobile Radio (SMR) signal energy. The ISCO solution replaced a significantly more costly and complex competitor's solution yet provided superior overall performance. The customer has now placed orders for more than \$700,000 of the new ISCO RF2 duplexer / filter solution for delivery during the fourth quarter 2007.

"While we are focused on the rollout of our fully digital adaptive interference management platform during the fourth quarter, this is an example of how we've been able to efficiently leverage our significant technical and operational assets to quickly address a significant need of a major customer," said John Thode, President and CEO of ISCO.
